mop. The auto-scrubber should be fitted with a non-aggressive cleaning brush or pad.

Do not perform regular maintenance with aggressive pads such as diamond-impregnated pads or other abrasives. Use of aggressive pads will wear away stain protection and, in time, wear away color from the concrete surface.

Clean auto-scrubber according to manufacturer's directions. After cleaning, allow to dry before resumption of traffic.

Between cleanings, remove dust and debris with a microfiber pad or dry mop. Check wear of floor on a regular basis to determine if Stain Protector needs to be re-applied.

Simply mix concentrated cleaner with water. Surfaces can be cleaned using a rag, mop or auto scrubber.

- Light Dirt & Auto-scrubber – Dilute 1oz cleaner per gallon of water
- Heavy Dirt – Dilute 2oz cleaner per gallon of water

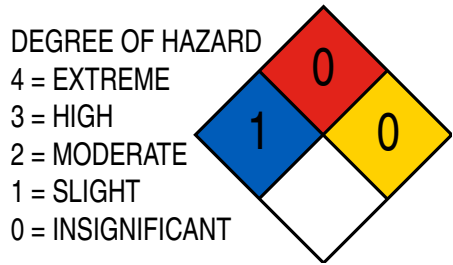
