#### PREPARATION

Protect people, vehicles, property, plants, windows and all non masonry surfaces from product, splash, residue, fumes and wind drift. Protect and/or divert foot and auto traffic.

For curing, concrete must be sound and properly finished. Existing concrete must be clean, dry and in good repair before sealing with DuraSheen.

Ensure fresh air entry and cross ventilation during application and drying. Extinguish all flames, pilot lights and other potential sources of ignition during use and until all vapors are gone. Avoid exposing passers by and building occupants to product, fumes and mist.

#### **Surface and Air Temperatures**

Do not apply when temperatures are less than 20°F (-6°C).

### **Equipment**

Apply by brush, long-nap roller, lamb's wool applicator or low pressure spray equipment. Fit spray equipment with steel or brass fittings and gaskets suitable for solvent solutions. Brushes and rollers should be nylon or other synthetic material resistant to solvent solutions. Avoid atomization.

## Storage and Handling

Store in a cool, dry place away from potential ignition sources. Keep tightly closed when not dispensing. Published shelf life assumes upright storage of factory-sealed containers in a dry place. Maintain temperature of  $45-100^{\circ}F$  (7–38°C). Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

#### **APPLICATION**

Before use, read "Preparation" and "Safety Information."

**ALWAYS TEST** each type of surface and coating for suitability and results before overall application. Test using the following application instructions. Let test area dry thoroughly before inspection.

#### **Dilution**

Do not alter, dilute or thin. Mix well before use.

#### **Curing New Concrete**

Apply as soon as surface water has disappeared and slab can support the weight of an applicator. Apply at 300-400 sq.ft./gal (7-10 sq.m./ liter). Coverage may vary based on porosity and texture of surface.

#### Sealing New & Existing Concrete

Surfaces must be clean, dry and in good repair.

On concrete already cured with DuraSheen, sealing with DuraSheen gives added protection. Apply after 28 days of curing.

On concrete not cured with DuraSheen, apply two coats. Add the second coat four hours after the first

#### **ALWAYS TEST**

ALWAYS TEST a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.
