### 4. FIRST AID MEASURES

**First aid measures****General advice**

Immediate medical attention is required.

<b>Eye contact</b>	Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Keep eye wide open while rinsing. Do not rub affected area.
<b>Skin Contact</b>	Immediate medical attention is required. Wash off immediately with plenty of water while removing contaminated clothing and shoes. If symptoms persist, call a physician.

## 5. FIRE-FIGHTING MEASURES
