**ADVANTAGES**

# Deep Sheen

## PREPARATION

Protect people, vehicles, property, plants, windows and all non masonry surfaces from product, splash, residue, fumes and wind drift. Protect and/or divert foot and auto traffic. Pavers must be clean, dry and in good repair before application.

Ensure fresh air entry and cross ventilation during application and drying. Extinguish all flames, pilot lights and other potential sources of ignition during use and until all vapors are gone. Avoid exposing passersby and building occupants to product, fumes and mist.

## Surface and Air Temperatures

Do not apply when temperatures are less than 40°F (4°C).

## Equipment

Apply by brush, long-nap roller, lamb's wool applicator or low pressure spray equipment. Fit spray equipment with steel or brass fittings and gaskets suitable for solvent solutions. Brushes and rollers should be nylon or other synthetic material resistant to solvent solutions. Avoid atomization of the material.

## Storage and Handling

Store in a cool, dry place away from potential ignition sources. Keep container tightly sealed when not dispensing. Published shelf life assumes upright storage of factory-sealed containers in a dry place. Maintain temperature of 45–100°F (7–38°C). Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

## APPLICATION

Before use, read "Preparation" and "Safety Information."

**ALWAYS TEST** each surface and type of stain for suitability, dilution rates and desired results before overall application. Use the following application instructions. Let surface dry thoroughly before inspection and approval.

## Dilution

Apply as packaged. Do not dilute or alter. Mix well before use.

## Coverage Rates

Coverage varies based upon paver porosity and texture. Always test.

### Concrete Pavers

- 40–60 square feet per gallon
- 4–6 square meters per gallon

### Clay Pavers

- 75–100 square feet per gallon
- 7–9 square meters per gallon

### Stone Pavers

- 200–400 square feet per gallon
- 19–37 square meters per gallon

## ALWAYS TEST

**ALWAYS TEST** a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.

## Application Instructions

Cover surface uniformly, creating a continuous film. Two coats may be needed for porous concrete pavers. Add the second coat four hours after the first. Two thin coats are always preferred over one heavy coat.

## Drying Time

At 80°F (27°C), treated surfaces dry:

To touch .....	25 minutes
Light foot traffic.....	4 hours
Normal traffic.....	Overnight
Maximum hardness.....	7 days

## Cleanup

Clean tools and equipment with Defacer Eraser® Graffiti Wipe, mineral spirits or similar solvent.

### **SAFETY INFORMATION**

Paver Kare® Deep Sheen is a solvent-carried product and may cause symptoms typical with organic solvent exposures. This is a combustible material. #### **First Aid**

### **BEST PRACTICES**

Do not use around pools, fountains or other water features.

Paver surfaces should be clean, dry and absorbent before application.

Clean soiled paver surfaces with Sure Clean® Light Duty Concrete Cleaner before application.

Preferred method of application is low-pressure spray equipment. Use a fan-type spray tip and adjust pressure to avoid atomization of the material.

Apply evenly. Be careful not to over apply.

Two coats may be needed for porous concrete pavers. Two thin coats are always preferable to one heavy coat.
