#### PREPARATION

Protect people, property, vehicles, and all non masonry surfaces that may come into contact with the product, spray, wind drift or fumes. Avoid exposing passersby and building occupants to product and mists.

The surface must be clean, dry and absorbent. Remove mud, rust, efflorescence or hard water staining with Sure Klean® Light Duty Concrete Cleaner. Remove general soiling, food-related stains, mold and mildew before application. Contact PROSOCO for additional cleaning recommendations as needed, toll-free at 800-255-4255.

Do not use raw acids.

Let cleaned surfaces dry completely. Allow freshly placed concrete, mortar, caulking or sealant compounds to cure before applying Paver Enhancer WB.

#### **Surface and Air Temperatures**

Surface and air temperatures must be 40°F (4°C) and rising. Do not apply when air temperatures exceed 90°F (32°C).

#### **Equipment**

Apply with brush, roller or low-pressure spray (<50 psi). Fan tips are recommended for sprayers. Do not atomize.

#### **Storage and Handling**

Keep from freezing. Store in a cool, dry place. Always seal container after dispensing. Do not alter or mix with other chemicals. Published shelf life assumes upright storage of factory sealed container in a dry place. Maintain temperatures of 40–100°F (4–38°C). Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

#### **APPLICATION**

Before use, read "Preparation" and "Safety Information."

**ALWAYS TEST** each type of surface for suitability and results before overall application. Test using the following application instructions. Let test dry thoroughly before inspection.

#### **Dilution**

Apply as packaged. Do not dilute or alter, or use for purposes other than specified.

Mix well before applying.

#### **Coverage Rates**

Coverage varies based on paver texture and porosity. Always test.

Porous, Textured Surfaces

- 60–100 square feet per gallon
- 6–9 square meters per gallon

#### Semi-porous Surfaces

- 100-150 square feet per gallon
- 9–14 square meters per gallon

Dense, Smooth Surfaces

- 150-300 square feet per gallon
- 14–30 square meters per gallon

#### **ALWAYS TEST**

ALWAYS TEST a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.

#### **Application Instructions**

#### Horizontal Surfaces

- Apply to a clean, dry surface using a brush, roller or low pressure sprayer. Apply enough material to keep the surface uniformly wet for 2 - 3 minutes before penetration.
- 2. Broom out puddles. Collect excess that does not penetrate with an absorbent towel.
- 3. Some surfaces need a second application to get the desired color enhancement. Let the surface dry 2-3 hours between coats.

#### **Vertical Surfaces**

Thoroughly saturate the surface. Use enough for a rundown of 6—8 inches below the spray pattern. Brush out heavy runs and drips.

#### **Drying Time**

Protect treated surfaces from foot traffic for at least 6 hours. Protect from vehicular traffic and rainfall for 24 hours. Allow 3 days for Paver Enhancer WB to gain its water-repellency properties.

### Cleanup

Clean tools, equipment and over spray with soap and warm water.

Paver surfaces should be clean, dry and absorbent before application.

Clean soiled paver surfaces with Sure Klean® Light Duty Concrete Cleaner before application.

Preferred method of application is lowpressure spray equipment. Use a fan-type spray tip and adjust pressure to avoid atomization of the material.

Apply evenly. Saturate the surface, but be careful of over application by brooming out puddles and wiping up excess, including runs and drips on vertical surfaces.

A second application may be needed on highly porous surfaces such as some concrete pavers. Let the first coat dry 2—3 hours before applying a second coat.
