Sure Klean[®] Custom Masonry Sealer is a clear, solvent-based silicone elastomer formulated to weatherproof custom masonry units, cast stone, architectural concrete block, precast concrete, wood and porous masonry. Custom Masonry Sealer penetrates and fills pores to prevent water penetration through exterior walls exposed to normal weathering.

Custom Masonry Sealer has excellent UV stability and provides long-lasting protection against water penetration and many types of graffiti. Easy to apply with low-pressure spray, brush or roller.

ADVANTAGES

Protect and/or divert pedestrian and auto traffic. Some metal finishes and glass may be damaged by Custom Masonry Sealer. Test and protect. Sure Klean® Strippable Masking is not appropriate for use with Custom Masonry Sealer. Ensure fresh air entry and cross ventilation during application and drying. Extinguish all flames, pilot lights and other potential sources of ignition during use and until all vapors are gone. When applying to exteriors of occupied buildings, make sure all windows, exterior intakes and air conditioning vents are covered and air handling equipment is shut down during application and until vapors have dissipated. Apply at recommended coverage rates as excess material may contribute to vapor problems.

Surface should be clean, dry and absorbent. If cleaning is necessary, use the appropriate Sure Klean® cleaner. Do not use raw acids. Let cleaned surfaces dry completely. Newly constructed surfaces and repointed surfaces should cure for 28 days before application. Sealing and caulking compounds should be in place and cured before application. Fill all cracks and voids to keep fumes out of buildina.

NOTE: Some floor and wall systems incorporate asphaltic or other cracksuppression membranes. This deeply penetrative protective treatment may penetrate through exposed stone, tile, grout or paver surfaces and react with the membrane to mobilize objectionable staining. Always pretest to ensure desired results.

ALWAYS TEST a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.

Custom Masonry Sealer may not be compatible with previously applied surface treatments. Carefully evaluate the appearance and wetting characteristics of surfaces designated to be treated. If a field or factory-applied treatment is detected, test to confirm compatibility or contact PROSOCO for advice on removal of the previous treatment.

Surface and Air Temperatures

If freezing conditions exist before application, let the masonry thaw. Surface and air temperatures should be at least 40°F (4°C) and not above 90°F (32°C) during application. Higher temperatures evaporate the solvent carrier and reduce penetration.

Equipment

Use brush, roller or low-pressure spray (<50 psi). Fit spray equipment with stainless steel or brass fittings and gaskets suitable for solvent solutions. Fan spray tips are recommended to avoid atomization of the material. Brushes and rollers should be nylon or other synthetic material resistant to solvent solutions.

Storage and Handling

Store in a cool, dry place away from potential ignition sources. Keep tightly closed when not dispensing. Published shelf life assumes upright storage of factory-sealed containers in a dry place. Maintain temperature of 45–100°F (7–38°C). Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

APPLICATION

Before applying product, read "Preparation" and "Safety Information."

ALWAYS TEST each type of surface for suitability and results before overall application. Product may darken some substrates. Test using the following application instructions. Let area dry thoroughly before inspection. Verify any darkening from the treatment is acceptable.

Dilution

Use in concentrate. Do not dilute or alter. Stir thoroughly before use. Keep container tightly sealed until ready to use. Once opened, Custom Masonry Sealer must be used immediately.

Application Instructions

Sprayer

- 1. Apply in a saturating "wet-on-wet", spray application from the bottom up. Apply sufficient material to create a 6–8 inch rundown below the contact point.
- Allow the first application to penetrate for 2-3 minutes and then reapply in the same saturating manner. Less material will be required on the second application.

When spray applying to fluted surfaces, spray in a "overlapping X-pattern" to ensure complete coverage of recessed surfaces.

When applying to burnished, ground face or similar smooth surfaces, use care to avoid over application. Reduce rundown to 4–6 inch below the contact point and pre-test to confirm desired results.

Extremely porous surfaces will require 2 coats. See instructions under Second Coat Application.

Brush or Roller

- When applying with a brush or roller, apply sufficient material to thoroughly saturate the surface.
- 2. Avoid excessive overlapping. Brush out runs and drips to avoid buildup.

Dense Surfaces

Apply a single coat. Use enough to completely wet the surface without creating drips, puddles or rundown. Do not over apply. Test for application rate.

Second Coat Application

Some surfaces may require 2 coats of Custom Masonry Sealer to provide maximum protection. Apply the second coat as soon as the first coat is dry to touch, or within 2 hours of the first coat. Allowing more than 2 hours between coats will reduce effectiveness of second coat.

Drying Time

Protect treated surfaces from rain for at least 4–6 hours after application. Custom Masonry Sealer gains its water-repellency properties in 24 hours.

Cleanup

Clean tools with mineral spirits.

Graffiti Removal

Remove most types of graffiti with PROSOCO's Defacer Eraser® Graffiti Wipe. Refer to information on PROSOCO's Defacer Eraser® product line for application to high-exposure areas.

BEST PRACTICES

Some metal finishes and glass may be damaged by Custom Masonry Sealer. Test and protect.

Custom Masonry Sealer may not be compatible with previously applied surface treatments. Carefully evaluate the appearance and wetting characteristics of surfaces designated to be treated. If a field or factory-applied treatment is detected, test to confirm compatibility or contact PROSOCO for advice on removal of the previous treatment.

Preferred method of application is lowpressure spray (<50 psi)equipment. Use a fan-type spray tip and adjust pressure to avoid atomization of the material.

Fan spray tips are recommended to avoid atomization of the material. Brushes and rollers should be nylon or other synthetic material resistant to solvent solutions.
